Basis for computation of VAT, i.e., based on Gross Amount per BIR Revenue Memorandum Circular No. 39-2007 or as prescribed per Detailed Cost Computation in the Bid Documents. 	<p>The requirements of DOLE-DO No. 18-A shall not apply pursuant to GPPB Resolution No. 26-2013 dated 26 April 2013 which reiterated the view expressed in -Policy Matter Opinion No. 03-2012 dated 30 November 2012 that Section 9 (b)(ii) of DOLE D.O. 18-A should be considered invalid for being violative of Section 31 of RA 9184 and its IRR¹.</p> <p>The VAT should be applied not only to the Administrative Profit Margin and Supplies Expense but to the whole contract price. Manpower agencies, such as those providing janitorial services are subject to VAT on their gross receipts based on the whole contract prices as reiterated in BIR ruling No. 213-2015 dated June 19, 2015. The said ruling clarified that RMC No. 39-2007 which excludes the personnel’s wages in computing the VAT is only applicable to security agencies and not to manpower agencies such as janitorial and clerical services.</p>


