<p>I. Eligibility Requirements</p> <p>Mayor's Permit</p>	<p>Per GPPB Resolution No. 2, s. 2015, submission of recently expired mayor's permit is allowed provided it will be submitted with the Official Receipt as proof that it has applied for renewal of the permit within the prescribed period and provided also, that the current and valid mayor's permit, as renewed, be submitted or presented by the bidder with the Lowest Calculated and Responsive Bid prior to award of contract</p>
<p>II. Technical Specifications</p>	
<p>Hardware Component</p>	
<p>1. Dedicated Video Graphic Adapter</p>	
<p>Will dedicated graphics be considered?</p>	<p>As per technical specification, it should be Dedicated Video Graphics Adapter, with at least 2Gb graphics memory. Bidder must provide through expansion slot including compatible cables.</p>
<p>Do you need a VGA port or bidders should provide a higher specification?</p>	<p>Bidder must provide an Integrated Built-in Video Graphic Adapter.</p>
<p>2. Power Supply</p>	
<p>Will 240 watts be acceptable since some of the commercial products released in the market today carry that wattage?</p>	<p>As per technical specification, the power supply should be 300 watts or higher.</p>
<p>3. Optical Drive</p>	
<p>Will 8x Optical Drive be considered?</p>	<p>As per technical specification, the optical drive should be 16x SATA DVD Multi-Recorder</p>
<p>4. Video</p>	
<p>Will DV to DVI Adapter be considered?</p>	<p>Yes.</p>
<p>5. Monitor to Desktop</p>	
<p>Is it wide or non-wide?</p>	<p>Wide.</p>

<p>1. Operating System</p>	

Will other licensing option (such as OEM) be acceptable even if Full Product is available?	As per technical specification, PPPC preferred Full Product Package
2. MS Project 2013	
Will open license program be acceptable?	As per technical specification, PPPC preferred Full Product Package
What is the validity of Level 1 Training for five (5) pax?	Training Voucher must be provided which is valid for one (1) year, reckoned from the date of delivery.
