**SUBJECT :** ATTENDANCE TO THE REGION-WIDE PUBLIC-PRIVATE  
PARTNERSHIP (PPP) ORIENTATION- WORKSHOPS

**DATE :** JUNE 8, 2012

The Department of the Interior and Local Government entered into a Memorandum of Agreement (MOA) with the PPP Center on October 11, 2011 to formalize its collaboration in capacitating local government units (LGUs) as they develop and undertake local infrastructure and development projects through Public-Private Partnership (PPP).

To date, region-wide PPP Orientation –Workshops have been successfully conducted in six (6) regions (Regions III, IV-A, VII, XI, CAR & CARAGA). For the next months, PPP Orientation Workshops are tentatively scheduled in the following regions with the goal of reaching out as many LGUs as possible:

Relative to this, all Provincial Governors, City/ Municipal Mayors are hereby encouraged to send two (2) technical staff preferably the designated Local Economic and Investment Promotion Officers (LEIPOs) and one (1) representative from the PPP Sub-Committee of the Local Development Council (LDC) to participate in the said PPP Orientation-Workshops. Travelling expenses, accommodation and meals during said activities are hereby authorized chargeable against their respective local funds, subject to the usual accounting and auditing rules and regulations.

All DILG Regional Directors are directed to coordinate closely with the PPP Center in the conduct of these orientation workshops, provide support in arranging the venues, preparation of invitation letters, and take charge in the confirmation of LGU participants.
