The PDMF

- ✓ Revolving fund
 - Project preparation and transaction support
 - ❖ Feasibility study
 - ❖ Project structuring
 - ❖ Bid documents, including PPP contract
 - ❖ Management of bid process
 - ❖ Assistance until financial close
 - Probity advisory services
 - Monitoring of PPP project implementation

PDMF Funds

- ✓ USD 18 million from Government of Australia, through ADB
- ✓ USD 80 million from GOP

Legal Basis

- ✓ Executive Order (EO) 8, series of 2010 as amended by EO 136, series of 2013
 - Mandated PPP Center to manage and administer the PDMF
 - EO 136 expanded PDMF scope to cover not only project preparation but also monitoring of PPP project implementation

Institutional Arrangement

PPP Governing Board

- Policy-making body for all PPP-related matters, including the PDMF

PDMF Committee

- Approves PDMF applications
- Sets the policy and implementation guidelines for the use of the PDMF and recovery of costs

PPP Center

- Administers and manages the PDMF
- Acts as secretariat to the PDMF Committee

Project Study Committee

- Reviews TORs and bidding documents for the selection of consultants
- Evaluates and accepts outputs of the consultants
- Endorses payments to the consultants upon acceptance of deliverables

Special BAC

- Conducts recruitment/selection of consultants
