As per bid, a Medium (General Engineering) Classification/License Category B is required. Does the Medium A pertain to a medium-size water supply project under the PCAB Registration	The entity proposed to meet the Construction Experience shall have at least a PCAB license of Medium A (General Engineering-Water Supply), License Category B which generally provides for the allowable range of contract cost for government projects which the company can bid for, regardless of the sector. A corresponding amendment of the ITPB shall read as follows: <i>“The entity proposed to meet the Construction Experience must possess a valid license issued by the Philippine Contractors Association Board (PCAB) for Medium A (General Engineering 4-Water Supply) Classification/ License Category B, in the case of Filipino Construction Experience Nominee, at the very least. The Single Largest Project Completed and Allowable Range of Contract Cost may apply to other government projects which are not necessarily in the water sector.”</i>
