**REHABILITATION OF MUNICIPAL SLAUGHTERHOUSE, OPERATION AND
MAINTENANCE OF THE WHOLE KALIBO MEAT PLANT**
INVITATION TO PRE-QUALIFY AND SUBMIT COMPARATIVE PROPOSALS

The Municipality of Kalibo is inviting interested parties to pre-qualify and submit comparative proposals in the Competitive Challenge for the selection of the Municipality of Kalibo's Joint Venture partner for the Rehabilitation of Municipal Slaughterhouse, Operation and Maintenance of the Kalibo Meat Plant ("Project").

On May 15, 2018, the Municipality of Kalibo granted Original Proponent Status to Philippine Slaughterhouse Management Operation, Inc. for its unsolicited proposal on the Project. On February 12, 2019, the Municipality of Kalibo and the Original Proponent signed a Joint Certification of Successful Negotiation.

The Project involves the rehabilitation of the existing Kalibo Slaughterhouse, and the operation and maintenance of the Kalibo Meat Plant for a period of Twenty-Eight (28) years. The estimated project cost is Thirty Million Pesos (Php 30,000,000.00).

The Project will be awarded pursuant to the Competitive Challenge process, rules and guidelines for unsolicited proposals and joint ventures prescribed in Resolution No. 2015-324 and Executive Order 021-2015 otherwise known as "An Executive Order providing the Implementing Rules and Regulations the Provincial Public-Private Partnership ("PPP") Code of the Province of Aklan for Kalibo PPP Projects".

The Two-Stage/Two Envelope System for the solicitation of the Comparative Proposals will be followed. In this process, potential challengers are first pre-qualified based minimum legal, technical and financial qualification requirements set by the Municipality of Kalibo. Only challengers who pre-qualify shall have their Technical Proposals opened for evaluation, and if determined to be technically compliant, will proceed to have their Financial Proposals opened for consideration by the Municipality of Kalibo

Interested parties must submit their written and notarized Expressions of Interest to participate in the Competitive Challenge by March 25, 2019, 5:00 PM at Kalibo Municipal Hall, Municipal Economic Enterprise and Development Office.

The PPP-SC shall furnish the Request for Proposals ("RFP") to the interested party after payment of a non-refundable fee of Twenty-Five Thousand Pesos (Php25, 000.00) (mode of payment; cash, check-made out to Municipal Treasurer of Kalibo). The date when the RFP will be made available for purchase and distribution at Kalibo Municipal Hall, Municipal Economic Enterprise and Development Office, Arch. Reyes St., Kalibo, Aklan will be announced through Bid Bulletin.

The RFP shall consist of: (1) this Invitation to Pre-Qualify and submit Comparative Proposals; (2) the Information Memorandum; (3) the Instruction to Bidders; (4) the Bid Forms; and (5) the Draft Joint Venture Agreement.


Only challengers who have purchased the RFP shall be allowed to participate in the Competitive Challenge. Purchasing the RFP does not constitute a guarantee of eligibility.

Challengers must submit in one package their Qualification Documents showing their legal, technical/track record, and financial capacities in accordance with the Instruction to Bidders not later than April 9, 2019, 10:00 AM at the Kalibo Municipal Hall, Municipal Economic Enterprise and Development Office, unless otherwise advised.

The Municipality of Kalibo reserves the right to accept or reject any or all Comparative Proposals at its discretion. Challengers shall bear all costs associated with their participation in the Competitive Challenge including the preparation and submission of their Comparative Proposals, and all possible losses or damages resulting therefrom. The Municipality of Kalibo shall not be held responsible or liable in any way for such costs regardless of the results of the Competitive Challenge.
