KEY TAKEAWAYS



- ❖ The Philippines has institutionalized **policies and issuances** to support sustainable energy strategies. These are aligned with the country's commitments for the United Nations 2030 Sustainable Development Goals (SDGs) as well as its development plans and priorities both at the national and regional/local levels.
- ❖ **Institutional arrangements** that involve national and local implementing agencies, oversight, and regulatory agencies/committees in this sector have been set up.
- ❖ The role of the private sector in both renewable energy/waste-to-energy projects through PPP options are provided for in the existing **PPP legal framework** (i.e. BOT Law and its Implementing Rules and Regulations, NEDA Joint Venture Guidelines, PPP Governing Board Policy Circulars)



KEY TAKEAWAYS

- ❖ **Private sector** interest, commitment, experience and resources (technology, innovation, financing) and commitment are present.
- ❖ Challenges are in the following areas:
 - ✓ **Policy and process enablers** (Local PPP/JV Codes; the National Solid Waste Management Commission; Energy Virtual One-Stop Shop or EVOSS; DENR Rules; PPP RE/WtE guidelines; templates; etc.)
 - ✓ **Institutional capacities** (in project structuring/ procurement/ implementation; staff/technical needs)
 - ✓ **Project identification and selection** (project scope/structure; commercial considerations; unsolicited proposals)
 - ✓ **Others** (terms of office; political/social concerns)



CALL FOR ACTION

❖ Policy and Process Enablers



- ✓ Finalize and issue the Implementing Rules and Regulations of the EVOSS Act under RA 11234 (An Act Establishing the EVOSS for the Purpose of Streamlining the Permitting Process of Power Generation, Transmission, and Distribution Projects) – **Department of Energy**
- ✓ Formalize and/or review Local PPP/JV Codes to include provisions for RE and/or WtE PPP options – **LGUs with Support from the PPP Center**
- ✓ Solid Waste Management Guidelines for PPPs – **PPP Center and DENR**
- ✓ Finalize and issue Department Administrative Order Guidelines on WTE – **DENR (and PPP Center)**
- ✓ National Solid Waste Management Commission (NSWMC) Resolution #669 Adopting the Guidelines Governing the Establishment and Operation of Waste to Energy Technologies for Municipal Solid Waste - **DENR and NSWMC**



CALL FOR ACTION

❖ Institutional Development

- ✓ Forge an inter-agency collaboration (Memorandum of Agreement) among concerned agencies (DOE, DENR, DILG, etc.) to come up with a framework that would fast track the development of PPPs in the RE/WtE Sectors – **PPP Center**

❖ Building PPP Capacities for RE and WtE PPPs

- ✓ Focused capacity building and technical guidance to selected LGUs – **PPP Center**
- ✓ Technical assistance to selected LGUs (through the PDMF, ADB CDTA-NCs, others) – **PPP Center**



CALL FOR ACTION

❖ Project Pipeline Development

- ✓ Pursue the Local PPP Strategy - **PPP Center** in collaboration with existing partners; **NEDA Regional Offices** (Regional PPP Knowledge Corners) and the **League of Cities of the Philippines (LCP)**

- ## ❖ Continue working with Development Partners (e.g. ADB, AFD, etc.) to facilitate support to PPP initiatives in sustainable energy sector(s)



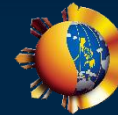
