

CONTRACT

THIS AGREEMENT number **2021-07** made on **FEB 22 2021**, 2021, between **Public-Private Partnership Center of the Philippines** (hereinafter the Purchaser) on the one part and **First Data Corporation**, (hereinafter the Supplier) on the other part.

WHEREAS the Purchaser has requested a quotation for the procurement of Server Software Licenses and User Client Access Licenses to be supplied by the Supplier, viz. **Supply and Delivery of Server Software Licenses and User Client Access Licenses (CALs)** (hereinafter Contract) and has accepted the bid by the Supplier for the supply of goods under the Contract for the sum of **Four Million Two Hundred Forty-Five Thousand and Four Hundred Twenty-Seven Pesos (PhP4,245,427.00)**, (hereinafter Contract Price).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. The following documents shall be deemed to form and be read and construed as part of this agreement, viz:
 - a. Request for Quotation; and
 - b. Terms and Conditions of Supply;
2. Taking into account payments to be made by the Purchaser to the Supplier as hereinafter mentioned, the Supplier hereby concludes an agreement with the Purchaser to execute and complete the supply of goods under the Contract and to remedy any defects therein in conformity with the provisions of the Contract.
3. The Purchaser hereby covenants to pay the Contract Price, in consideration of the acceptance of Contract, for the supply and delivery of the goods and remediation of defects therein in accordance with Payment Conditions prescribed by the Contract.


