## Invitation to Apply for Eligibility and to Submit a Proposal Baggao Water Supply Project (RE-BIDDING)

The Municipality of Baggao, through its Joint Venture (JV) Selection Committee – invites Private Sector Participants (PSP) to apply for eligibility and to submit a proposal for the Baggao Water Supply Project. Details of the Project are as follows:

Project Scope	The Baggao Water Supply Project involves the design, financing, construction, testing, operation and maintenance of a Level III Water Supply System which includes the following components: (a) water source development; (b) treatment, pumping and storage facilities; (c) transmission and distribution services; and (d) billing and collection services.
Project Objective	Provision of 24/7 Level III water service conforming to the Philippine National Standards for Drinking Water (PNSDW)
PPP Scheme:	Joint Venture Arrangement pursuant to Municipal Ordinance No. 2022-08 series of 2022 or the "Municipality of Baggao JV Code"
JV Term	25 years, inclusive of 18 months construction period
Bidding Format:	Simultaneous or Single-stage Qualification and Bidding

A complete set of Bidding Documents consisting of the (1) Instructions to Private Sector Participants (ITPSP) including Schedules and Annexes; (2) draft JV Agreement; and (3) Project Information Memorandum (PIM), may be acquired by interested PSP starting from May 26, 2023, from the given address below and upon payment of the applicable fee for the Bidding Documents, in the amount of Twenty Thousand Pesos (Php 20,000.00).
