In case of any conflict between the information and terms in this IM and the Instructions to Private Sector Participants and Instructions to Eligible Bidders, the information and terms in the Instructions to Private Sector Participants and Instructions to Eligible Bidders shall prevail.

No person has been authorized to give any information or make any representation not contained in this IM and, if given or made, any such information or representation may not be relied upon as having been authorized by the Municipality and any other agency of the Philippine Government.

1.0. PROJECT DESCRIPTION

1.1. Site Overview

Baggao is a first-class municipality located in the Province of Cagayan, Region II (Cagayan Valley). Based on the 2020 Census of Population and Housing, Baggao recorded a total population 87,753 of people, making it the most populous municipality/area next to Tuguegarao City. is politically Baggao subdivided into barangays and has a total land area of 920.60 square kilometers.



Baggao produces high yields of rice, corn and tobacco, which are considered its major agricultural resources. Aside from farming, the town is widely known for crafting furniture from Narra lumber, which is abundant in the locality.

Bounded by the Sierra Madre Mountains and the Pacific Ocean, Baggao is located 62 kilometers north of the provincial capital of Cagayan, Tuguegarao City, and is approximately 517 kilometers north of Metro Manila. The town boasts several scenic tourist attractions such as the Duba Underground River and Cave in Barangay San Miguel; the Blue Water Falls and Cave in Barangay Pallagao; and the Kamimundinan Falls in Barangay Sta. Margarita.

1.2. Project Scope and Component

The Baggao Water Supply Project (the "Project") involves the design, financing, construction, testing, operation and maintenance of a Level III Water Supply System which includes the following components:

- (a) Development of raw water sources;
- (b) Planning, development, designing, building, and commissioning of the facility;
- (c) Management, operation and maintenance of the facility;
- (d) Supply of the treated water to Customers within the Service Area:
- (e) Financing of the above activities; and
- (f) Collection of Private Sector Partner (PSP) Revenue, all in accordance with the Joint Venture Agreement.

1.3. Project Objectives

The Project aims to provide 24/7 Level III water services that conforms to the Philippine National Standards for Drinking Water (PNSDW) to twenty-four (24) barangays.

Currently, the Municipality of Baggao does not have a Level III water service (Level III water service is defined as a system with distribution pipelines wherein individual metered service connections are tapped to supply water to the customers directly through their faucets). Majority of the population get their water through their own-built shallow wells or deep wells.

1.4. Service Coverage Area

The Project entails the development of at least two (2) independent systems covering twenty-four (24) barangays of Baggao. The service coverage area of these systems are as follows:

2.0. TECHNICAL REQUIREMENTS AND STANDARDS

2.1. Minimum Requirements

The design of the facility shall comply with the minimum requirements set forth in the Minimum Performance Standards and Specifications (MPSS). Below are the minimum design criteria, among others:

2.1.1. Demand Projections

2.1.3. Raw Water Sources

The facility should be supplied by at least two (2) operating raw water sources at all times during the JV Term from different locations. Raw water sources should be able to carry a minimum combined capacity of 70 liters per second. The PSP is not restricted to develop groundwater sources, surface water from the nearby rivers, springs, water falls, etc. maybe development as well.

2.1.4. Pumping Facilities Capacity: Maximum Day Demand (MDD) / Operating hours

2.1.5. Storage Facilities (Reservoir): Twenty five percent (25%) of ADD The PSP may use of other available technology that can deliver the equivalent reservoir capacity and system performance.

2.1.6. Transmission and Distribution System

2.1.7. Treatment Facilities

The PSP shall recommend, for the approval of the Grantor, the appropriate treatment facilities (e.g. chlorinating equipment) to be installed.

3.0. LEGAL FRAMEWORK

3.1. Project Structure

The Project will be implemented thru a PPP scheme under a Joint Venture (JV) Agreement pursuant to Municipal Ordinance No. 2022-08 series of 2022 or the "Municipality of Baggao JV Code". The scheme will involve the premises and the terms and conditions specified in the "Contractual Joint Venture Agreement for the Provision of Water Supply for the Municipality of Baggao, Cagayan" between the Municipality and the PSP.

3.2. Cost of the JV Activity / Project1

The estimated cost of the JV activity/Project is PhP 210,638,936.00. This includes the estimated capital expenditure of the Private Sector Proponent (PSP) amounting to PhP 201,283,692.00, based on 2021 prices, and the contribution of

the Municipality amounting to Php 9,345,244.00 representing cost of the project site, and the existing water system facilities.

3.3. Bid Parameter

The bid parameter is lowest initial water charge for residential customers for 0 - 10 cubic meter), subject to the approval of the regulatory body.

3.4. Expected Contract Terms

The Project shall have a term of twenty-five (25) years inclusive of inclusive of eighteen (18) months construction period as defined under the JV Agreement, unless extended for reasons acceptable to the Municipality.

3.5. Competitive Selection Process²

The Joint Venture – Selection Committee (JV-SC) of the Municipality, created through Executive Order No. 32, Series of 2022 ("An Order Creating Joint Venture-Selection Committee for the Establishment of Baggao Water Supply Project of the Local Government Unit of Baggao, Cagayan"), shall administer a Competitive Selection Process for the Project.

The Competitive Selection Process shall be conducted in accordance with the rules and procedures for competitive selection using a Single-Stage/Simultaneous Qualification process.

3.6. Indicative Timeline³

The Joint Venture – Selection Committee (JV-SC) of the Municipality shall administer a Competitive Selection Process for the Project. The said process shall follow the indicative timetable below:

4.0 SALIENT ELIGIBILITY REQUIREMENTS

1. <u>Legal Requirements</u>. The Bidder PSP must be duly registered with the SEC and be at least sixty percent (60%) Filipino-owned. If a Consortium, the ownership interest of Filipino Consortium Members in the Consortium must be at least sixty percent (60%).

2. <u>Technical Eligibility Requirements.</u>

Design:

 The Bidder PSP must have experience in having successfully undertaken, detailed design and engineering of at least one of the following: Level 3 Water Supply Project, and/or bulk water supply projects, and/or water facilities projects such as pipeline, water treatment, pumping, water reservoir, and the like.

Construction Experience:

 The Bidder PSP, or a related entity as described below, must have satisfactorily undertaken, the construction, testing and commissioning of at least one of the following: Level 3 Water Supply Project, and/or bulk water supply projects, and/or water facilities projects such as pipeline, water treatment, pumping, water reservoir, and the like.

Operation and Maintenance Experience:

- The Bidder PSP, or a related entity as described below, must have experience in the Operation and Maintenance of at least one of the following: Level 3 Water Supply Project, and/or bulk water supply projects, and/or water facilities projects such as pipeline, water treatment, pumping, water reservoir, and the like.
- 3. Financial Eligibility Requirements. The PSP must have the following:
 - (a) a Net Worth, or (2) a Set-Aside Deposit of at least Sixty Million Three Hundred Eighty-Six Thousand Pesos (PhP 60,386,000.00) or its equivalent.

In case of Net Worth, it shall be based on its latest audited financial statements, which must be for a financial year ending not earlier than 31 December 2022 (if available, otherwise the latest audited financial statements dated not earlier than 31 December 2021, with a written explanation why those for 2022 are not yet available).

(b) evidence that it has the capability to raise loans of at least One Hundred Forty Million Eight Hundred Ninety-Nine Thousand Pesos (PhP140,899,000.00) for the Project.
