CONTRACT AGREEMENT

THIS CONTRACT, made this 14th day of June 2024 between:

The PUBLIC-PRIVATE PARTNERSHIP CENTER OF THE PHILIPPINES, an agency of the Government of the Republic of the Philippines attached to the National Economic and Development Authority (NEDA) by virtue of Executive Order No. 8, Series of 2010 and Republic Act No. 11966 or the Public-Private Partnership (PPP) Code of the Philippines, with principal office at 8th Floor, One Cyberpod Centris, EDSA cor. Quezon Ave., Brgy. Pinyahan, Quezon City, Philippines, hereinafter referred to as "PPP CENTER" (also "CLIENT" or "PROCURING ENTITY") and represented by its Executive Director, MA. CYNTHIA C. HERNANDEZ.

- and -

SYCIP GORRES VELAYO & CO. [in association with Pacific Rim Innoviation and Management Exponents, Inc. (Philippines), Gatmaytan Yap Patacsil Gutierrez & Protacio (Philippines) and Colliers International Philippines, Inc. (Philippines)] as subconsultants], with principal office at 14/F SGV Building, 6760 Ayala Avenue, Makati City, Metro Manila, Philippines, hereinafter referred to as the "CONSULTANT" and represented by its Partner, MARIE STEPHANIE C. TAN-HAMED.

The PPP Center and Consultant shall be collectively referred to as "Parties".

ANTECEDENTS

On December 21, 2023, the Head of Procuring Entity approved the recommendation of the Special Bids and Awards Committee (SBAC), through Resolution No. 2023-009, on the following:

- To resort to negotiated procurement Section 53(d) of RA 9184 and Section 53.4 of the RA 9184 IRR (Adjacent or Contiguous Contract) for the NEDA sa Makati Property Redevelopment Project;
- To issue a Supplemental Annual Procurement Plan and the necessary negotiation documents for the negotiated procurement under Section 53(d) of RA 9184 and Section 53.4 of the RA 9184 IRR prior to negotiation with the existing Consultant for the aforesaid Project; and
- To authorize the SBAC to negotiate with the existing Consultant for the
 continuation of the remaining services under the pre-existing Contract for
 Consultant's Services (CCS) for the Project through an adjacent or
 contiguous contract following negotiated procurement under Section 53(d) of
 RA 9184 and Section 53.4 of the RA 9184 IRR.

On December 22, 2023, the Supplemental Procurement Plan, which includes the Procurement of Project Preparation Services for the NEDA sa Makati Property Redevelopment Project under Section 53.4 of the IRR of RA 9184, was signed by the authorized signatories of the PPP Center.

On December 27, 2023, the SBAC issued the Invitation for Negotiated Procurement to the Consultant.

On January 2, 2024, the Consultant submitted the legal, technical, and financial eligibility documents requested by the SBAC in response to the Invitation for Negotiated Procurement.

On January 5, 2024, the negotiation between the PPP Center and the Consultant was held. The negotiations with the Consultant successfully concluded on March 27, 2024.

On May 25, 2024 , the Notice of Award was issued and conformed with by the Consultant.

The PPP Center and the Consultant then executed this negotiated Contract, with the conformity of the National Economic and Development Authority (NEDA). The Contract covers the Project Preparation and Transaction Advisory Services for the NEDA sa Makati Property Redevelopment Project wherein the Consultant agreed to undertake the Services in the contract amount of Thousand Two Hundred Thirty Seven 92/100 US Dollars (USD 271,237.92), inclusive of taxes.

NOW THE PARTIES AND THE NEDA AGREE AS FOLLOWS:
