

CONTRACT AGREEMENT

THIS CONTRACT, made this 4th day of July 2024 between:

The **PUBLIC-PRIVATE PARTNERSHIP CENTER OF THE PHILIPPINES**, an existing agency of the Government of the Republic of the Philippines attached to the National Economic and Development Authority by virtue of Executive Order No. 8, Series of 2010 and Republic Act No. 11966 or the Public-Private Partnership (PPP) Code of the Philippines, with principal office at 8th Floor, One Cyberpod Centris, EDSA cor. Quezon Ave., Brgy. Pinyahan, Quezon City, Philippines, hereinafter referred to as "**PPP CENTER**" (also "**CLIENT**" or "**PROCURING ENTITY**") and represented by its Executive Director, **MA. CYNTHIA C. HERNANDEZ**.

- and -

JOINT VENTURE OF DELOITTE TOUCHE TOHMATSU INDIA LLP, ASA LAW FIRM, PHILKOEI INTERNATIONAL INC. AND ORIENT INTEGRATED DEVELOPMENT CONSULTANTS, INC., each member will be jointly and severally liable to the Client for all the Consultant's obligations under this Contract, represented by its lead member, **DELOITTE TOUCHE TOHMATSU INDIA LLP**, in association with Romulo Mabanta Buenaventura Sayoc & De Los Angeles as sub-consultant, with principal office at 7th Floor, Building 10 Tower B, DLF Cyber City Complex, DLF City Phase II, Gurgaon 122 022, Haryana, India, hereinafter referred to as the "**CONSULTANT**" and represented by its Partner, **SUDEEP KUMAR SINHA**.

The PPP Center and Consultant shall be collectively referred to as "**Parties**".

ANTECEDENTS

On December 22, 2023, the Head of Procuring Entity approved the recommendation of the Special Bids and Awards Committee (SBAC), through Resolution No. 2023-009, the following:

1. To resort to negotiated procurement Section 53(d) of RA 9184 and Section 53.4 of the RA 9184 IRR (Adjacent or Contiguous Contract) for the NCR EDSA Busway Project (**Project**);
2. To issue a Supplemental Annual Procurement Plan and the necessary negotiation documents for the negotiated procurement under Section 53(d) of RA 9184 and Section 53.4 of the RA 9184 IRR prior to negotiation with the existing Consultant for the aforesaid Project; and
3. To authorize the SBAC to negotiate with the existing Consultant for the continuation of the remaining services under the pre-existing CCS for the Project through an adjacent or contiguous contract following negotiated procurement under Section 53(d) of RA 9184 and Section 53.4 of the RA 9184 IRR.

On December 22, 2023, the Supplemental Procurement Plan, which includes the Procurement of Project Preparation Services for the Project

under Section 53.4 of the IRR of RA 9184 was signed by the authorized signatories of the PPP Center.

On December 27, 2023, the SBAC issued the Invitation for Negotiated Procurement to the Consultant.

On January 3, 2024, the Consultant submitted the legal, technical, and financial eligibility documents requested by the SBAC in response to the Invitation for Negotiated Procurement.

On January 5, 2024, the contract negotiation between the PPP Center, Department of Transportation (DOTr), and the Consultant was held. The negotiations with the Consultant successfully concluded on March 19, 2024.

On April 12, 2024, the Notice of Award was issued and conformed with by the Consultant.

On June 3, 2024, the Consultant posted the Performance Security which was deemed compliant by the PPP Center in the prescribed form and amount.

The PPP Center and the Consultant then executed this negotiated Contract with the conformity of DOTr. The Contract covers the Project Preparation Services for the NCR EDSA Busway Project wherein the Consultant agreed to undertake the Services in the contract amount of **One Million Seven Hundred Thirteen Thousand Twenty and 40/100 US Dollars (USD 1,713,020.40)**, inclusive of taxes.

NOW THE PARTIES AND DOTR AGREE AS FOLLOWS:

1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.


